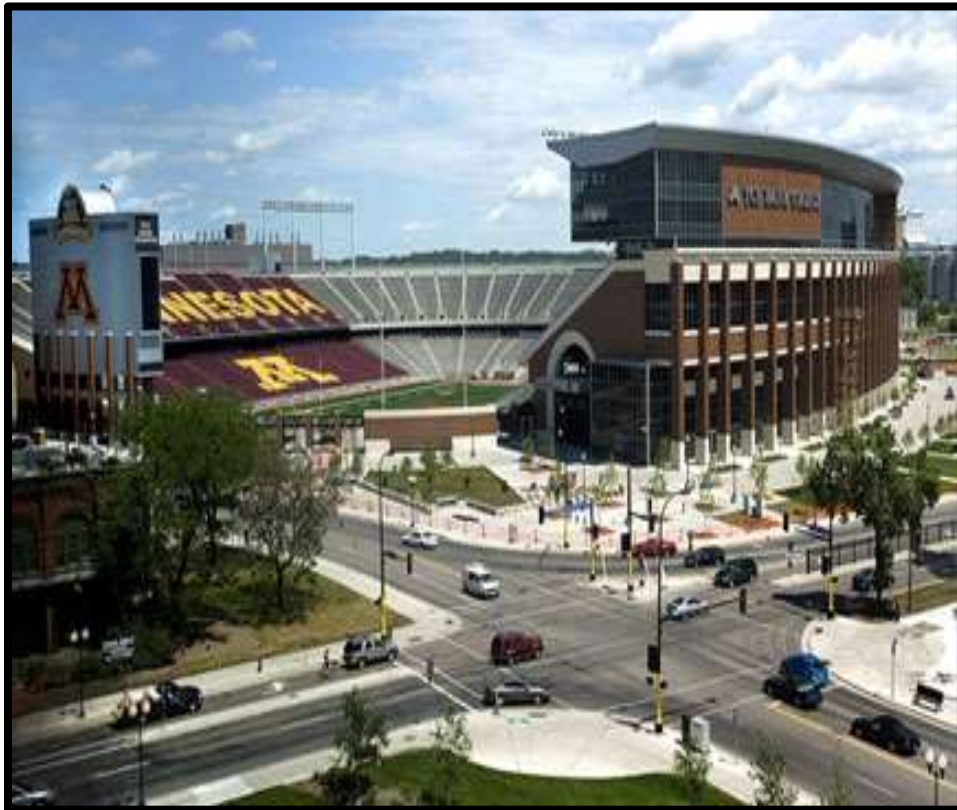


23rd Annual Upper Midwest Collegiate Football Officiating Clinic

This clinic has built its reputation as a premier and informative clinic format using both classroom sessions and on-field instruction. We strive to advance participants knowledge and understanding of NCAA rules, enforcements and mechanics. The clinic offers an opportunity to work several scrimmages while receiving feedback from observers.

Clinic Overview

This is our 23rd annual clinic using a classroom presentation outlined by position and working a collegiate scrimmage. Scrimmages will be held at one of the following NCAA schools: Minnesota State University Mankato, Concordia University St. Paul, University of Minnesota Duluth, University of South Dakota, Minnesota State Moorhead University, Augustana, Sioux Falls SD and Winona State University.

The classroom presentation will be conducted by Missouri Valley, Mid-American and Big Ten officials' sharing information relevant to your specific position in breakout sessions. Instruction will include mechanics, positioning and enforcements.

Your instruction will be on-field and may include post-game review. In some cases, we will be able to review video from the scrimmage for additional feedback.
